WHEREAS, I, C. F. Liverett, in the State aforesaid, SEND GREETING:

Fifteen Hundred Dollars,

conditioned for the payment of the monthly sum of Twenty Five Dollars, of each and every month succeeding the

date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for

attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

NOW, KNOW YE, ALL MEN BY THESE PRESENTS, that I, C. F. Liverett,

in consideration of the said date and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to

the said C. F. Liverett,

in hand, well, and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,

the said C. F. Liverett,

have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that plot of land, in said State and County, in the City of Greer, on the

side of Merchant Street.

Beginning at an iron pin on said Merchant Street and running thence with said street S. 88-03 E. 80.5 feet to an iron pin, thence S. 9-30 E. 147.5 feet to an iron pin thence S. 80-30 W. 100 feet to an iron pin thence Northward to the beginning corner on Merchant Street.

Also, all that other piece parcel or lot of land situate, lying and being in the State and County aforesaid, in the Town of Greer, Chick Springs Township, on the west side of Albert Street and having the following metes and bounds to wit:

Beginning on Albert Street at the corner of Lot #18 and running thence S. 9-30 E. 60 feet to the corner of Lot #20, thence with the line of Lot #20 S. 80-30 W. 106.6 feet to corner, thence N. 2-56 W. 58.8 feet to the line of Lot #17 and #18, thence N. 80-30 E. 100 feet to the beginning corner.
