D. W. P. Beckman in the State aforesaid, SEND GREETING:WHEREAS, *D*, the said *D. W. P. Beckman*in and by *my* certain Bond or Obligation of even date herewith stand firmly held and bound unto CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, in the full sum of*Eight Hundred Dollars*, conditioned for the payment of the monthly sum of *Thirteen and 54/100* Dollars,on the first Tuesday *fifth* of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for*ten per cent* attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.NOW, KNOW ALL MEN, That *D* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to *CITIZENS BUILDING AND LOAN ASSOCIATION* to said *D. W. P. Beckman*County, South Carolina at *before the sealing and delivery* of these presents, the receipt whereof is hereby acknowledged, *I* the said *D. W. P. Beckman*have granted, bargained, sold and released and by these presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the City of Greer, on the *Locality**side of Merchant Street.*

Beginning at a stake on Merchant Street and runs thence $26^{\circ} 30' 06''$ N. to a stake on line of lot #10 thence $S. 80^{\circ} 30' 00''$ E. 66.3 feet to a stake; thence $N. 0^{\circ} 14' 00''$ W. 238.4 feet to a stake on said Merchant Street thence $S. 88^{\circ} 03' 00''$ E. 60 feet to the beginning corner. Being a portion of lot #17 and lot #19 on a plat of land called Merchant place, also all that lot of land situated, lying and being in the state and County aforesaid on the south side of Merchant Street in Greer, Beginning at a pin on Merchant Street and running thence $S. 0^{\circ} 14' 00''$ E. 549.3 feet to a pin; thence with the line of a road in $S. 78^{\circ} 18' 00''$ W. 157 feet to a stake on bank of road; thence $N. 0^{\circ} 33' 00''$ E. 343.3 feet to street; thence when Merchant Street $S. 89^{\circ} 01' 00''$ E. to the beginning corner, being lot #16 on map made by H. Clegg Jones of the Merchant place and known as the Merchant Homes.
