Having the following metes and bounds, to wit: -
 Beginning One hundred feet from the intersection
 of the Pelham Road with a cross road, on the
 Mrs. M. L. Jones line, and runs thence with
 said Pelham road 100 feet to an iron pin, thence
 S. 62-35 E. 200 feet (measuring from the center of said
 Pelham Road) to an iron pin; thence 100 feet to an
