Brown*,in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to *me*, the said *S. P. Brown*,in hand, well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, *I*, the said *S. P. Brown*.have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, ^{near} in the City of Greer, on the *South* side of *Parkers Silverside* Street.

Having the following metes and bounds: All that lot of land in said State and County, near the City of Greer, being known as lot No. 3, Block 1, on a plat made by W. S. Brockman, Surveyor April 21, 1919, and having the following metes and bounds: to wit: Beginning at a stake on the South side of Pennsylvania Ave. and running thence N. 13-25 E. 120 feet to a stake on Alley, thence S. 76-35 E. 70 feet to a stake on alley, thence N. 13-25 E. 120 feet to a stake on Pennsylvania Ave. thence N. 73-35 E. 70 feet along said Avenue to the beginning corner, this being the same lot of land conveyed to me by E. J. Mann Master in deed bearing the date of October 5th 1925.
