CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, in the full sum of \$3,000.00 Dollars,

conditioned for the payment of the monthly sum of \$150.00 Dollars, on the first Tuesday in each month of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for

attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

Birrines, Deacons of Southern Bleachery Baptist Church, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to W^e. B. B. Bishop, Robert Keeler, B.B. Cox, G. A. Skinner and J. E. Birrines, Deacons of Southern Bleachery Baptist Church, in hand well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville

County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,

the said W^e. B. B. Bishop, Robert Keeler, B.B. Cox, G. A. Skinner and J. E. Birrines, Deacons of Southern Bleachery Baptist Church, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the following manner,

Beginning at a point on the right side of the center of the Piedmont-Northern Highway, said highway, said beginning being at the corner with the end of said Street, being 56 feet from the front yard line, thence forward said Street, with a radius of 89° 109' feet to 100 feet, it then goes along a tangent of 90° N. 50 E. 56 feet to S. 100 E. 13.5 feet from the center of the Piedmont-Northern Highway; thence forth in angles of 90° 109' feet to the beginning, and so will more fully appear in a plan plat made by J. E. Birrines & Company, Engineers, beginning date November 23, 1925; a copy of which is now attached and being filed in the office of the County Clerk of Greenville County, South Carolina, to witness by J. E. Birrines, Deacons of Southern Bleachery.
