WHEREAS, *S. L. Wallace*,

in and by *S. L. Wallace* certain Bond or Obligation of even date herewith stand firmly held and bound unto CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, in the sum of *500.00* Dollars, conditioned for the payment of the monthly sum of *Twenty five dollars* *per month* of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for *legal fees* attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *J. P. Waters*, the said *S. L. Wallace*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to *S. L. Wallace* to said *S. L. Wallace* received *92* in hand, well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, the said *S. L. Wallace* have granted, bargained, sold and released and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the City of Greer, on the *South* side of *Arlington Ave.* *Street*.

Severing the following lands and bounds, to-wit: The said *S. L. Wallace* lot in the edge of Arlington Ave. (Delby J. W. Smith lot) and running thence with J. W. Smith's line, S. 17-50 W. 195.8 feet to an iron rail fence, whence N. 5-45 E. 30.6 feet to an iron rail fence off J. W. Smith's lot that fronts on *Greer Street*. thence 107.4 feet to iron rail (R. M. Headrop's estate line) thence with Headrop line N. 17-15 E. 135 feet to an iron fence in the edge of Arlington Ave; thence with Arlington Ave. 155.4 feet to the beginning corner. This being the two lots containing the Arlington Ave. property on that known as *lot 2 of J. W. Smith in R. Stone* and *J. P. Waters lots*, said tract made by J. P. Brockman, Surveyor, *Plan* recorded March 18, 1926, and being the same lot conveyed to me by J. W. Smith and J. W. Stone.
