Gairson*.*At*#*6220*have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, in the City of Greer, on the *South**H. B. Bailey* side of *Maud* Street.

corner of *E. 1st* *St.* and *Maud* *Ave.*, and Being known and designated as Lot no. 9 as shown on the Subdivision and Plat of *M. T. Gairson* property, made by *A. Christopher*, Surveyor, under date of June 14th, 1923 and having the following lines and bounds and courses and distances, as shown by said Plat, 10 acr.:-
