All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being a part of the subdivision known as "McCullough Heights" and lot No. 26 acre per plat, said subdivision made by R. W. Parker on May 1, 1918 which plat is recorded in R. M. C. office for said County and State, plat book 8 page 95, reference to which is hereby made. This conveyance is subject to the following conditions and restrictions: The said subject shall be used for residential purposes for white people only (this not to apply to servants) and no residence shall be erected on this lot to cost less than one thousand and five hundred Dollars and the purchaser hereof his or her heirs, executors, administrators or assigns shall be amenable to reasonable sanitary rules and regulations as set forth in deed Colonial Company to Jas. A. McCullough of date April 28th. 1913 and recorded in R. M. C. office Vol. 25 page 4.

The above described land is the same conveyed to Jas. A. McCullough by Colonial Company on the 22nd day of October 1909 deed recorded in office of Register of Deeds Conveyances for Greenville County in Book XXX, Page 95; and on April 28th. 1913 recorded Vol. 25 Page 4. This being the property conveyed to me by the said Jas. A. McCullough, deed dated December 8th, 1923, recorded in office of R. M. C. Greenville County, Vol. 57, page 566.
