J. Baling* his Deputy, *W. O. Ellington* Esq.,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece of land or lot of land in Greenville Townships, Greenville County, South Carolina, near the Anderson Road known as Lot No. 19 on plat of lands of American Bank and Trust Company made by R. E. Dalton, Engineer, and recorded in Plat Book 1, page 44, said lot having the following widths and bounds according to said plat:

Beginning at an iron pin on the North-East side of Jamison Street corner of lot No. 20 (which pin is 107 feet S. 53-40 E. from Pine Street) and running thence with line of lot No. 20 N. 42-42 E. 200 feet to iron pin in line of lot No. 8, thence with line of lot No. 8 N. 53-40 E. 95 feet to iron pin corner of lot 18, thence with line of said lot N. 42-42 W. 200 feet to iron pin on Jamison Street, thence with Jamison Street N. 53-40 W. 55 feet to the beginning, being the same bounded to *L.
