WHEREAS, I, the said A. S. Parker

in and by my certain promissory note in writing, of even date with these presents, Am

well and truly indebted to Rudolf Anderson

in the full and just sum of Five Thousand

Dollars, to be paid on or before February 20th 1924

with interest thereon, from February 20th 1923 at the rate of eight per cent. per annum to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent. besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Rudolf Anderson, his heirs and assigns forever

All that certain ~~real~~ parcel or lot of Land, situate, lying and being in the County of Greenville, State aforesaid, Known and designated as Lot # 30 on a plat of a survey made by J. H. Patrick Ferry Company Engineers September 1919 of the property of Ables & Rason and being more particularly described as follows: Beginning at a point on the South side of Riverside Drive, 358 feet from the Southeast intersection of Augusta Road and Riverside Drive, joint corner of lot # 30 and 31 and running thence in a line parallel with Augusta Road 170.3 feet to a point, joint corner of lots 30, 31, 38, and 39 and running thence in an easterly direction, parallel with Riverside Drive 176.5 feet to a point joint corner of lots 29, 30, 39 and 40 thence in a northerly direction parallel with Augusta Road 171.6 feet to a point on the South side of Riverside Drive, joint corner of lots 30 and 29; thence along a line on the South side of Riverside Drive 74 feet to the point of beginning and being the same lot conveyed to me the said A. S. Parker, by Rudolf Anderson by his deed dated February 21st 1923 not yet recorded.
