WHEREAS, I, the said *W. D. Workman*, in and by my certain promise, even date with these presents, am well and truly indebted to

*F. G. Mouldin*

in the full and just sum of Twelve hundred (\$1200.00) Dollars, payable in three Dollars, to be paid equal annual installments, on the 17th day of August in the years of 1926, 1927 and 1928, should at any time any part of the principal or interest of the first note and mortgage become past unpaid, then this note and mortgage is to become immediately due and due and payable at the option of the holder.

with interest thereon, from date at the rate of eight per cent. per annum to be

computed and paid *Remainder annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said *W. D. Workman*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *W. D. Workman*, the said

in hand well and truly paid by the said

*F. G. Mouldin*

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

*F. G. Mouldin*, his heirs and assigns forever, all that certain lot of land in the City of Greenville, County of Greenville and State of South Carolina, on the south side of West Washington Street, and being known as lot No. 9 on a plat of the property of *W. D. Workman* said plat recorded in the office of the R. M. C. for Greenville County in plat Book 16" at page 293. Plat made by *R. E. Dalton, C.E.*

Beginning at the northeast corner of lot No. 9 and running thence in a south easterly direction S. 46-36 E. 18.99 feet; thence running in a north easterly direction N. 43-21 E. 75.3 feet; thence running in a north westerly direction N. 46-36 W. 20 feet; thence running in a south westerly direction S. 42-30 W. 75 feet to the point of beginning.

This mortgage is given to secure the credit portion of the purchase price.
