Smith all that piece, parcel, tract or lot of land situated in Greenville Township, Greenville County, State of South Carolina,

about 2 miles east of Greenville Courthouse on the Old Spartanburg Road containing one acre more or less, and bounded by lands of John Thompson, Hattie Brown et al.
