 and released, and by these presents do grant, bargain, sell and release unto the said *Julia D. Charles, Attorney*

 all that piece, parcel, tract or lot of land situated in *Greenville* *lot 2* *1931*  
 Township, Greenville County, State of South Carolina,

Known as lot No. 2 on a plat of *W.C. Adams and Herbert Fowler* recorded in Plat Book 3, page 36, said plat being a division  
 of part of lot 23 of Eastover, and having the following lines and  
 boundaries: Beginning at the iron pipe on Decewood Avenue 32.1  
 feet from intersection of Decewood Avenue and Mountain View Avenue,  
 at corner of lot 23, in said street and running thence north east  
 toward Avenue S. 32-30 E 50 feet to iron pipe at corner of lot 23 and
