WHEREAS, I, the said N. A. Wallace, in and by my certain Penitentiary even date with these presents, am J. G. Mauldin, in the full and just of Eighteen Hundred (\$1800.00) Dollars, payable in three Dollars, to be paid equal installments, on the 17th of August, in the years 1926, 1927, and 1928; should at any time any part of the principal or interest of the first note and my mortgage become past due and unpaid this note and mortgage is to become immediately due and payable at the option of the holder, date, with interest thereon, from at the rate of 10 per cent. per annum to be computed and paid annually.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said N. A. Wallace his heirs and assigns forever, all that certain lot of land known as Lot No. 5 on a plat of the property of W. D. Workman, recorded in the office of the R. M. C. for Greenville County and State of South Carolina, beginning at the Southeast corner of Lots No. 5 and 6 and running N. 46-36 E. 21 feet, thence N. 40-30 E. 16.9 feet, thence N. 46-36 W. 21 feet, thence S. 42-30 W. 16.4 feet to the point of beginning. Said above referred to plat being recorded in Plat Book "E" at page 293 in said office.
