interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten dollars.

west of East North street and being described as follows:

Beginning at the intersection of two 10 foot alleys and
just west of lot of C. M. E. Church and running N. 8° 45' W.
40 feet to an iron pin; thence S. 81° 15' W. 46 feet and 9 inches
to an iron pin on a 10 foot alley; thence along said alley
