All those two certain pieces, parcels or lots of land in
the State and County aforesaid and in the City of
Greenville situate lying and being on the east side of
Pettingale street, known and designated as Lot #1 & 2
as shown by plat of I. W. D. Neves dated Nov. 1st, 1921 and
are a part of subdivision made by said Neves for H. H.
Griffith and hence particular described as follows;

Lat' Bot. 1. Beginning at the northeast intersection of said
Pettingale and Whitsett streets and running thence N. 16° 0' E.
60 feet, thence N. 82° 37' E. 40' feet, thence S. 0° 21' W. 47' feet
to Whitsett street thence along said street S. 77° 35' W. 95.6
feet to the beginning corner.

Lat' No. 2. Beginning at a point on the east side of
Pettingale street at the corner of Lat' no. 1 and running
thence N. 16° 0' E. 60 feet, thence S. 82° 37' E. 60' feet, thence
S. 0° 21' W. 47' feet to line of Lat' no. 1, thence along the
line of that lot S. 82° 37' W. 97' 11" feet to the beginning
