grant, bargain, sell and release unto the said A. H. Schader his heirs and executors

All that certain piece, parcel or lot of land, situate  
lying and being in the City of Greenville, State and  
County aforesaid, being a portion of Bayee Addition  
to Greenville, and being known and designated as  
lot no. 42, block "D", according to survey of J. W. Adams  
July 1909, a plat of which is recorded in R. M. Co.  
Office for Greenville County in plat A, page 383  
and having the following lines and boundaries, to wit:  
Beginning at an iron pin on the south side of  
East Washington, joint corner with lot no. 41 and  
42; thence in a southerly direction 175 feet to an  
iron pin on Bayee Street; thence in a  
westerly direction along said Avenue, 50 feet to an  
iron pin, joint corner with lot no. 43 and 44  
thence in a northerly direction 175 feet to a pin
