added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereto had, as will more fully appear.

grant, bargain, sell and release unto the said

All that certain piece, parcel or lot of land situate, lying and being in the State of
South Carolina, County of Greenville and in the City of Greenville, situated on the South
side of Hampton Avenue in said City and described by metes and bounds as follows, to-wit:
Beginning at a stake on the South line of Hampton Avenue sixty-one and 75/100 feet from
the southeast corner of said Hampton Avenue and Mulberry Streets and running thence in a
Southerly direction, along a line parallel to the East line of Mulberry Street, One hundred
two and 75/100 feet to a stake; thence in an Easterly direction, along a line parallel to
the South line of Hampton Avenue Forty-one feet to a stake; thence in a Northerly direction
along line parallel to the said East line of Mulberry Street, One hundred two and 75/100
feet to a stake on the South line of Hampton Avenue; thence in a westerly direction along
the said South line of Hampton Avenue forty-one feet to the place of beginning.
It is the intention hereof to convey a lot of land forty-one feet in width off of the East
side of that certain lot of land heretofore conveyed by Mattie F. Latimer to T.F. Johnson
et al. Trustees, by deed recorded in R.I.C. Office in Book H.H.U. at page 54, referenced
to which deed is hereby made.
