WHEREAS, *Hayes M. Hargrave*, the said

DOLLARS, to be paid on or before the date when the *13th of April 1928* series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if... fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being hereunto had, will more fully appear.

Hargrave*, in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION, and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION

All that certain lot of land in the County and state aforesaid in the city of Greenville in the subdivision known as Loverset Park and being known and numbered as lot number one as follows of said subdivision and recorded in Plat Book No. 10 at page 96 and 97 showing the following lines and boundaries: Beginning at iron pin on the north side of State Street, corner of State B. Hart and the lot herein conveyed, thence with the northern sides of State Street, N. 75° 45' W. 60 feet to iron pin, corners later nos. 72 and 71, thence with joints lines of said lots N. 14° 15' W. 188 feet to iron pin, thence N. 75° 45' E. 60 feet to iron pin, corner of lot of State B. Hart, thence with the lines of the lot of State B. Hart S. 14° 15' E. 188 feet to the beginning corner, being thus square lots of lot as surveyed to me by J. E.
