County in Plat Book 7, page 426 Beginning at  
stake in line of lot Nos. 74 and 75, 100 feet, feet  
from line of lot No. 72, and running thence *W.*  
*64-20 E. 96 3* feet to Beechwood Avenue, thence with  
said Avenue *S. 71-55 E. 112 1* feet to Arden Street,  
thence in a curved line with diameter of 28' feet  
to iron pipe on Arden Street, thence still with  
Arden Street 156 feet to stake in line of lot No.
