with interest thereon, from date computed and paid Interest Annual until paid in THE DEBT HEREBY SECURED IS PAID IN FULL AND THE LIEN OF THIS INSTRUMENT IS 6th June 1928 is satisfied, plus Life Insurance premium for assignment of the Liberty Life Insurance policy assigned to me for the sum of Three Dollars.

NOW, KNOW ALL MEN, That the said Amelia Ruth Hollingsworth in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Amanda C. Austin, Cornelia C. Cobb and Nellie C. Brown according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me, the said Amelia Ruth Hollingsworth in hand well and truly paid by the said Amanda C. Austin, Cornelia C. Cobb and Nellie C. Brown at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Amanda C. Austin, Cornelia C. Cobb and Nellie C. Brown, All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on University Street, and having the following metes and bounds, to-wit:

Beginning at an iron pin on University Street at a point 161 feet from the intersection of Augusta Street and University Street, and running thence N. 38 E. 83 feet to an iron pin; thence N. 47-3/4 W. 77 feet to a ten-foot alley to be established; thence with said alley and in a line practically parallel with Augusta Street S. 36-1/2 W. 87 feet, more or less, to an iron pin on University Street at a point 78.4 feet from the beginning corner; thence with said University Street in a southeasterly direction 78.4 feet to the beginning corner.
