with interest thereon, from date when at the rate of per cent. per annum, to be computed and paid as above.

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10%

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That the said Frank W. Bennett, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Dale Rattner,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to Hannie, the said J. J. Dunn Rattner,

in hand well and truly paid by the said Frank W. Bennett,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Dale Rattner,

all that certain parcel, piece or lot of land lying and being in the State and County aforesaid and having the following lines and bounds: Beginning at a point on Prohawk Street, J. A. Johnson corner and thence with the Johnson line 210 feet to Hawkins line, thence with the said Hawkins line 135 feet to E. H. Moon line, thence 209 feet to Prohawk street, thence with the said Prohawk street 135 feet to the beginning corner and being the same lot of land conveyed to Lee McMath in his name P. Moon by deed dated January 6, 1921 and being the same lot of land conveyed to Hannie L. Moon by J. J. & F. Agler by deed recorded in office R. M. C. Greenville County, Vol. 51, page 164.
