I, Bettie S. Whitmire

10% of the amount due besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage), as in and by the said note, reference being thereunto had, as will more fully appear.

bargain, sell and release unto the said *American Bank & Trust Company*, its successors & assigns: All that certain lot of land in the city of Greenville County and state, aforesaid having the following metes and bounds to wit: Beginning at the Southeast corner of West McBee Avenue, and Academy Street, thence in a southerly direction 145 feet along Academy Street to an alley; thence in an easterly direction along said alley 66.4 feet to a point on Stiles line; thence in a northerly direction 145 feet along Stiles line to McBee Avenue; thence in a westerly direction 52.8 feet to the beginning corner, known as my old Home Place.
