WHEREAS, I, Hawkins Ashmore, the said Hawkins Ashmore

Dollars, to be paid One year after date

with interest thereon, from date at the rate of Eight per cent. per annum, to be
computed and paid annually

until paid in full; all interest not paid when due bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent. of
amount hereof besides all costs and expenses of collection, to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,

All that certain piece parcel or lot of land situate
lying and being in Paris Mountain Township
County and State aforesaid containing one-half
(1/2) acre more or less and described as follows;
Beginning at an iron pin in the center of the road
known as the Duncan Chappell road and about
50 yards from where said road runs into or inter-
sects with the Buncombe road and running thence
with said Duncan Chappell road in the direction
of Reedy River Church one hundred and fifty-six
(156) feet to an iron pin in the center of said
road, thence in a 'western direction and perpendi-
cular' to said Duncan Chappell road one hundred
and fifty-six (156) feet to an iron pin, thence in
a 'northern direction and parallel' to said Duncan
Chappell road one hundred and fifty-six (156)
