SEND GREETING:

WHEREAS, *I*, the said *H. A. Hawkins*  
in and by *my* certain *promissory* note in writing, of  
even date with these presents, *am* well and truly indebted to

*The Farmers Bank, Travelers Rest, S.C.*  
in the full and just sum of *Three Hundred Twenty-four & 83/100 (\$324.83)*  
Dollars, to be paid *one year after date*

with interest thereon, from *maturity of the note* at the rate of *8* per cent. per annum, to be  
computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
