in and by my

Being known and designated as lot No. 10, as shown on Plat of Property of H. J. Martin, made by L. M. Furman, Jr., Engr. 1927, and recorded in Plat Book 88, at page 139 office of the R. M. C. for Greenville County. Said lot fronts fifty feet on Hill Top Avenue, runs back one hundred and fifty feet at the corner of Edwards Street.

I, Emmie R. Thackston, Administrator and Trustee of the Estate of Mrs. Annie T. Goodlett, the owner and holder of a real estate mortgage executed to me by H. J.
