WHEREAS, I, Hallie H. Stubberfield

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Thirty-five hundred (\$3500.00) DOLLARS,

to be paid on or before the date when the 17-A Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable
