with interest thereon, from *date* the rate of *8* per cent. per annum, to be computed and paid *semi-monthly*

until paid in full; and interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.*

besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

in hand well and truly paid by the said *Farmers Bank Travelers Rest* at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said *Farmers Bank Travelers Rest*

All that certain piece parcel or tract of land situate lying and being in the County and State aforesaid, in *Butler Township* containing *23.98* acres more or less, and being a portion of tracts 4 and 5 of the *Hambly Farm* according to a plat made by *Citypatrick Kerr Co. May 1920* and having the following notes and bounds to-wit:

Beginning at a public road which leads from *Mauldin* to the *Dr. Miller Place* at an *pin* and at the corner of the tract conveyed by me to *W. B. and Otis Henderson* and running thence with said road as a line to *pin* in line of the *J. M. Bramlett* land, thence with said *Bramlett* line, *S. 74-27 E. 699.7* feet to rock, thence still with said *Bramlett* line, *N. 14-50 E. 967.8* feet to iron pipe corner of tract *No. 3*, thence with line of tract *No. 3*, *N. 64-42 W. 1276.8* feet to the beginning corner.
