with interest thereon, from date at the rate of six per cent. per annum, to be  
computed and paid annual all as 'annum' *Mar 1st*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten dollars (\$10.00) besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note

bargain, sell and release unto the said W. D. McBrayer:

All that certain piece, parcel or tract

County and state aforesaid, and being known  
and designated as tract No. 1 of the sub-  
division and plat of the W. D. McBrayer  
and J. P. Charles land made by J. P. Willis  
Surveyor, April 1918 and noted of record  
in the R. M. C. office for the County and  
state aforesaid in Plat Book "E" at page  
294, and containing 1/46 acres more or  
less. The foregoing land is a part of  
the tract of land conveyed by P. A. Huff  
to P. D. Huff Trustee by deed dated August  
23, 1866 and of record in the R. M. C. office  
for the County and state aforesaid in  
Deed Book "A" page 223 and is bounded
