

acknowledge payment of said mortgage in full, and do hereby empower J. W. Lanford Register of Mesne Conveyances to give satisfaction of the same upon the records of said with interest thereon, from the 1st day of November 1925 at the rate of 7 per cent. per annum, to be computed and paid monthly until paid in full; all interest not paid when due to bear interest at the same rate as principal, and any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, and the holder hereof, who may sue thereon and foreclose this mortgage, further providing for an attorney's fee of Three Dollars and made good by the mortgagor, and besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by or for the mortgagor, or any kind, (all of which is secured under this mortgage), as in and by the said note, reference being thereunto had, as will more fully appear.

KNOW ALL MEN BY THESE PRESENTS, that the said J. Virginia M. Price in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Norwood National Bank, Greenville, S.C. according to the terms of said note, and also in consideration of the further sum of Three Dollars, to Virginia M. Price in hand well and truly paid by the said mortgagor

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said Norwood National Bank, Greenville, S.C.

its successors and assigns:

All of my undivided right, title and interest of in and to all of that tract of land situate in Butley Township, in the county and state aforesaid, and which belonged to my mother, Kissiah Miller, at the time of her death, my interest therein belongs to me as her heir at law and distributee in her estate. Said tract of land contains 593 acres, more or less. It lies on both sides of the main Highway leading from Spartanburg, Redville etc to Greenville. An action has been brought in the court of common Pleas for the petition of said land among the heirs at law of my mother, aforesaid, and tract No. 6 hereinafter described has been, by order of that court, allotted to me, but the deed has not yet been executed and delivered to me therefor. It is the intention of this mortgage, that when said deed is executed and delivered to me that the lien hereof attaches specifically to land hereinafter described and automatically ceases to be a lien on any other lands belonging to said estate. Said tract No. 6 allotted to me as aforesaid is more particularly described as follows:

Beginning at an oak in line of tract No. 5 just south of the aforesaid road, and runs thence S. 64. 45 E. 15. 20 to a stone; thence crossing said road N. 84. 25 E. 16. 80 to a stone; thence N. 14. 43 W. 60. 50 to a stone; thence N. 20. 15 W. 4. 75 to a stone; thence S. 87. 45 W. 11. 94 to a stone; thence S. 3. 45 E. 11. 42 to a pipe; thence S. 3. 45 E. 43. 22 to the beginning corner, containing 130. 45 acres more or less, and is contract No. 6 as shown on plat of the division of the Miller estate, made by C. M. Furrman, August 1919.
