SEND GREETING:

WHEREAS, I, the said J. Sauer, in and by my certain 1925 even date with these presents, Della R. Ellis, in the full and just sum of Five Hundred : (\$500.00)

Dollars, to be paid as follows: Sixty-five (\$65.00) Dollars at the end of each and every consecutive three months, until paid in full, the first payment to be due May 3rd, 1925;

with interest thereon, from 1st day at the rate of 8 per cent. per annum, to be computed and paid semi-monthly.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of the first least:

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof if the same to be placed in the hand of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said J. Sauer, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Della R. Ellis,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, 00, the said J. Sauer,

in hand well and truly paid by the said Della R. Ellis,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said Della R. Ellis

all that certain piece of land situate lying and being in the County and State aforesaid in the City of Greenville, on the south side of East Stone Avenue, known and designated as Lot No. 66, Section "H" of the Stone Land Co., according to plat of same recorded in the R. M. C. Office for Greenville County in Plat Book "A" page 327. Said lot having a frontage on Stone Avenue of 63 feet and running back in parallel lines a distance of 175 feet, more or less.

Being the same lot of land conveyed to me by the said Della R. Ellis by deed of even date herewith, the same not yet recorded; and this mortgage is given to secure the credit portion of the purchase price therefore.
