until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

10 per cent besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said R. D. Dobson the following

described real estate:

I, I, that is, parcel or tract of land on the Rutherford road in Greenville Society, state of South Carolina, near Taylors, and containing 2 acres, and having the following metes and bounds aforesaid courses and distances, as shown by plat of same made by W. A. Hester, Surveyor on December, 1921, as follows:

Beginning at an iron pin on the Rutherford road and running thence N. 56 1/4 W. 2.48 to iron pin, thence S. 33 3/4 E. 3.18 to stone orn; thence N. 17 1/4 E. 1.45 to iron pin N. M; thence N. 33 3/4 E. 6.90 to stone M; thence S. 48 3/4 E. 3.40 to stake now on the Rutherford road, thence along said road S. 33 3/4 W. 3.42 to the beginning corner and being a part of the land conveyed to King Green by E. Duncan Master, and being the same lot of land conveyed to me by King Green his deed dated December 12th, 1921.
