*B. O. Allen* in the full and just sum of *One Thousand (\$10,000.00)* Dollars, to be paid *One year after date*

with interest thereon, from *Date* at the rate of *Six* per cent. per annum, to be computed and paid *Annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

*A reasonable amount* besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.

All that certain lot of land situate, lying and being in the County of Greenville and State of South Carolina in the City of Greenville, on East Washington Street, Ward four, fully described as follows: Beginning at an iron pin on East Washington Street, Mr. Weldon's corner running thence with said Weldon's property S. 19 W. 180.0 feet (more or less) to an iron pin on back corner and on the old George line, thence N. 71 W. 16.0 feet to an iron pin between N. 19 E. 47.0 feet to another iron pin in the center of a ten foot alley driveway, containing thence in like manner direction and in the center of the said alley driveway 103.0 feet to an iron pin on East Washington Street; thence with said East Washington Street, S. 73 E. 46.0 feet to the point of beginning.
