WHEREAS, I, the said *J. L. Johnson et al. (Balleranger)*, in and by every certain *Promise to pay* note in writing, of even date with these presents, *do owe and promise to pay* well and truly indebted to *Oscar H. Hodges, Attorney* in the full and just sum of *Fourteen Thousand Four Hundred and Four Dollars*, Dollars, to be paid *One year after the date hereof* *and interest thereon, from the date of payment until paid in full, at the rate of eight per cent. per annum, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.*

NOW, KNOW ALL MEN, That I, the said *J. L. Johnson et al. (Balleranger)*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Oscar H. Hodges, Attorney*, according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me, the said *J. L. Johnson et al. (Balleranger)*, in hand well and truly paid by the said *Oscar H. Hodges, Attorney*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said *Oscar H. Hodges, Attorney*,

All that certain lot or parcel of land situate in the State of South Carolina, Greenville County, designated as Tract no. 55 plat no. 2, property of Parker Land Company surveyed by A. S. Wedell April, 1915 with subsequent changes and more particularly bounded and described as follows: Beginning in the center of the corner of the road in the H.B. Middle line the southwest corner of tract 64 runs thence with the Boundary line, S. 64 1/2 W. 31 chs. 50 links to the center of the Poor House Branch, the southeast corner of tract 55; thence up the center of the Poor House Branch and with the line of tracts 53, 36. 64 1/2 W. 7 chs. 63 links to a point in the center of the said branch, the southwest corner of tract 54; thence with the line of tract 54, 36. 64 1/2 E. 18 chs. 90 links to the center of the Parker Roads, in the line of tract 64, and the southwest corner of tract 54; thence with the center of said road and the line of tract 64, S. 28 E. 7 chs. 33 links to the beginning corner, containing 15 acres, more or less.
