Dollars, to be paid *Payable one (1) year after date*.

with interest thereon, from *Date and to when* at the rate of *Eight* per cent. per annum, to be computed and paid *quarterly*, *and* *interest* *accrued* *and* *due* *as of* *July 1927*

.....until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *fees full collect*.

.....besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,

bargain, sell and release unto the said *H. N. Barnes, Attorney*, his heirs and assigns, all that piece parcel or lot of land in Greenville, County and State aforesaid known as lot no. 10 of Block "D" of the Sterling Tract as shown on plat recorded in plat book page #9 and transcribed to book "B" page #81 and having the following metes and bounds: Beginning at an iron pin on the west side of Minus Street, one hundred (100) feet from the northwest corner of Minus and Valentine Streets and running thence Minus Street N. 47° 45' 8.30 feet to an iron pin, corner of lots no. 11 N. 44-36 W. 149.9 feet to an iron pin, thence S. 47-45 W. 51 feet to an iron pin, corner of lot no. 9, thence west line of lot no. 9 S. 44-50 E. 130 feet to an iron pin on Minus Street the beginning corner aforesd being the same lots conveyed to me by Marie McMinis by deed of even date herewith to be recorded.
