WHEREAS, I, the said P. T. Jones

in and by certain Promissory Note in writing, of even date with these presents, well and truly indebted to

A. D. L. Barksdale in the full and just sum of Six Hundred (\$600.00)

Dollars, to be paid One year after date.

with interest thereon from date at the rate of 8 per cent. per annum, to be computed and paid Semi Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all that certain piece, parcel or lot of land situate, lying and being in Greenville Township, County and State aforesaid, fronting on the South side of Blassingame Street (near the Augusta Road) and being lot No. 5 according to plat of property of James T. and Liba C. Mayes made by W. C. Dalton, Engineer, October 1922, and recorded in Plat book "F" at page 141 and having the following metes and bounds to-wit.

Beginning at an iron pin on the South side of Blassingame Street, joint corner of lots nos. 4 and 5 and running thence with line of lot No. 4 S. 26-30 E. 199.5 feet to a point in line of property of J. A. Marlowe Estate, thence with the Marlowe line S. 63-37 W. 60 feet joint corner of lots nos 5 and 6 thence with line of lot No. 6 N. 26-30 W. 199.4 feet to an iron pin on Blassingame Street, thence with Blassingame Street N. 63-30 E. 60 feet to the beginning corner.
