SEND GREETING:

WHEREAS, *I*, the said *J. T. Barton*,
in and by *A* certain *promisee*
even date with these presents, *and*
A. B. Holtzclaw.
in the full and just sum of *Two Hundred Dollars*.
Dollars, to be paid *One Hundred Dollars and interest July 8th, 1926 and
balance July 8th 1927*

with interest thereon, from *date* at the rate of *8* per cent. per annum, to be
computed and paid *monthly* until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.*

All that piece, parcel or lot of land in Chicks Springs
Township, Greenville County, State of South Carolina, having
the following metes and bounds:

Beginning in main street 12 foot
distance from the edge of the pavement at the corner of lot
#3 and run thence with said street N. 80-30 E. 25 feet to the
corner of lot #4; thence along the line of this lot S. 9-21 E.
270 feet; thence N. 85-15 W. 25 feet to the corner of lot #2;
thence along the line of lot #2 N. 9-30 W. 285 feet to the
beginning corner, being designated as lot #3 of the tract of L. W.
Hall, made by W. A. Christopher, Surveyor, April 5th. 1925.
