All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the city of Greenville on the south-west corner of Robinson and Craft Streets, known as lot No. 7 on plat of Greene Heights, and having the following courses and distances: Beginning at an iron pin at the southwest corner of Robinson and Craft Streets and running thence with Craft Streets N. 85-25 W. 100 feet to iron pin; thence S. 1-50 W. 50 feet to iron pin, thence S. 85-25 E. 100 feet to iron pin on Robinson Street, thence with Robinson Street N. 1-50 E. 50 feet to the beginning.
