WHEREAS, Truing S. Barksdale the said

in and by my promissory note in writing, of even date with these presents, well and truly indebted to

Dollars, to be paid Ninety days after date

with interest thereon from date at the rate of 8 per cent. per annum, to be computed and paid quarterly until paid in full.

IF ANY PORTION OF THE PRINCIPAL OR INTEREST BE AT ANY TIME PAST DUE AND UNPAID, THEN THE ENTIRE AMOUNT EVIDENCED BY SAID NOTE TO BECOME IMMEDIATELY DUE, AT THE OPTION OF THE HOLDER HEREOF, WHO MAY SUE THEREON AND FORECLOSE THIS MORTGAGE; AND IN CASE SAID NOTE SHOULD BE PLACED IN THE HANDS OF AN ATTORNEY FOR SUIT OR COLLECTION, OR IF BEFORE ITS MATURITY IT SHOULD BE DEEMED BY THE HOLDER THEREOF NECESSARY FOR THE PROTECTION OF HIS INTEREST TO PLACE, AND THE HOLDER SHOULD PLACE, THE SAID NOTE OR THIS MORTGAGE IN THE HANDS OF AN ATTORNEY FOR ANY LEGAL PROCEEDINGS, THEN IN EITHER OF SAID CASES THE MORTGAGOR PROMISES TO PAY ALL COSTS AND EXPENSES, INCLUDING 10 PER CENT. OF THE INDEBTEDNESS AS ATTORNEY'S FEES TO BE PAID BY THE MORTGAGOR IN CONNECTION WITH SAID MORTGAGE INDEBTEDNESS, AND TO BE SECURED UNDER THIS MORTGAGE AS A PART OF SAID DEBT.

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as lot No. 62 on a plat of Alta Vista property of the said R. B. R. Land Development Co., which plat is recorded in the office for Greenville County in Plat Book G, at page 20 and is more particularly described as follows: Beginning at an iron pin at the S. W. corner of Oliver Street and Aston Avenue and runs thence S. 4.15 W. 200 feet along Aston Avenue to an iron pin; thence N. 85-40 W. 62.5 feet to corner of lot no. 61; thence N. 4.15 E. 200 feet along line of lot 61 and 62 to Oliver Street; thence along the south side of Oliver Street S. 85.40 E. 62.5 feet to the beginning corner.
