Their successors and assigns, all that certain piece, parcel or lot of land situate, lying and being on the South side of Hampton Avenue, in the city of Greenville, County and State aforesaid.

Beginning at a point on the South side of Hampton Avenue 64 feet from East side of Gray Street and running thence with South Side of Hampton Avenue north 33 1/4, south 42 feet, thence with side of J. D. Rainey to an iron pin on Pine Street; thence with Pine Street, south 3 1/2 feet 40 feet, more or less; thence with line parallel with Raizes since 103 feet, more or less, to beginning corner, said lot having a width of 42 feet and running from Hampton Avenue to Pine Street.
