with interest thereon from date at the rate of 7 per cent. per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for a legal proceeding, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said W. J. Button

All that certain piece, parcel or lot of land situate, lying and being in Ward 6 of the City of Greenville, State and County aforesaid and having according to a survey made by P. E. Dalton, Engineer November 1927 the following poles and boundaries to-wit:

Commencing at an iron pin at the corner of South End Street and Cleveland Street and running thence along the line of South End Street N. 25° 30' W. 368 ft. to an iron pin; thence along line of grant or N. 62° 53' W. 190.3 ft. to an iron pin on line of H. B. McDaniel property; thence along line of H. B. McDaniel property S. 26° 42' E. 95.6 ft. to an iron pin on Cleveland Street; thence along the North side of Cleveland Street S. 60° 35' E. 330.2 ft. to the point of beginning. Containing one acre more or less, being the same land this day conveyed to me by W. J. Button by deed, yet unrecorded, this being a supplemental-money mortgage to secure part of the purchase price.
