WHEREAS, I, H. W. Estes,

SEND GREETING:

in and by certain Promissory Note made in the County of Greenville, State of South Carolina, on the 1st day of March, A.D. 1911, between H. P. & Co. M. M. & Co., Plaintiffs, and H. W. Estes, Defendant, in writing, of even date with these presents, are witnesseth, that the Plaintiff, H. P. & Co. M. M. & Co., have been granted a full and just sum of One Thousand Dollars, to be paid personally, at the rate of six percent per annum, to be computed and paid semi-annually, on the 1st day of March and September, until paid in full; all interest not paid when due shall bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after recording, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note, or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said H. P. & Co. M. M. & Co., Trustees, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said H. W. Estes, in hand well and truly paid by the said H. P. & Co. M. M. & Co., Trustees,

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. P. & Co. M. M. & Co., Trustees,

All that certain Piece, Parcel, or lot of Land, described as follows, being known and designated as "Lot No. 10, Block E" in a subdivision known as Buist Circle, according to Plat thereof recorded in R. M. C office for Greenville County in Plat Book "C" Page 10 and having according to said Plat the following metes and bounds, to wit;

Beginning at a stake on south side of Buist ave. 200 ft. west of Townes St. Extension, and running thence along Buist ave. N. 80-15 W. 100 ft. to a stake corner lot no. 10; thence with line of lot no. 10 S. 9-45 W. 156 ft. to a stake on Wharton Ave (now called Ashley Ave); thence due East 100.2 ft to a stake corner of lot no. 12; thence with line of lot no. 12 N. 9-45 E. 140 ft. to the beginning corner,
