until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness, attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that lot of land situate in and near the City of Greenville, County and State of South Carolina, on the East side of Jones Avenue, being given as part of Lots 1 and 2 off Jones Street of the property of A. H. McDaniel, which said plat is recorded in the Plat Room Office for Greenville County in Plat Book #1 at page 186, said lots 1 and 2 having been recut by the mortgagor as shown by plat of C. M. Furman Jr., dated February 15th, 1929, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the East side of Jones Avenue, 105 feet north of my property, and running thence S. 87-00 E. 181.5 feet to an iron pin; thence S. 101 E. 52.83 feet to an iron pin; thence N. 89-00 E. 183.4 feet to an iron pin on the East side of Jones Avenue; thence along the East side of Jones Avenue, N. 1-00 E. 52.5 feet to the point of beginning.
