WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Thirty eight hundred and eight dollars

Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain, piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

Known as lot no Thirty-two (32) on plat of property of L. L. Bailey recorded in plat book 6 page 1 in R. M. C. Office of Greenville County and having according to said plat the following metes and bounds: Beginning at an iron pin joint corner of lots thirty-two and thirty-three (32 and 33) and running thence N. 45-20 E. one hundred twenty (220) feet to an iron pin joint corner of lot no. thirty-three (33) and running thence along line of lot thirty-three (33) and running thence along line of lot thirty-two (32) S. 45-20 E. one hundred and six feet to iron pin corner of lot no. thirty-one (31) and running thence along line of lot thirty-one (31) S. 45-20 E. one hundred fifteen and seven tenths (215.7) feet to an corner of lot thirty-one (31) and running thence along Larcher Street: thence along corner, S. 45-20 E. sixty-five feet to the beginning corner, S. 45-20 E. thirty-six and thirty-seven (36 and 37) and running thence along line above referred to and having according to said plat the following metes and bounds: Beginning at an iron pin on Larcher Street points corner of lots nos. Thirty-five and thirty-six (35 and 36) and running thence S. 45-20 E. one hundred and twenty feet to an iron pin corner of lot no. Thirty-eight (38); thence along line of lot thirty-eight (38) n. 44-40 E. two hundred forty-five and seven tenths (245.7) feet to iron pin on right-of-way of L. & W. C. R.R.; thence along said right of way n. 49-47 W. one hundred twenty and thirty-six thousandths (120.36) feet to iron pin corner of lot thirty-five (35); thence along line of lot thirty-five (35) S. 44-40 W. two hundred thirty-six and four tenths (236.4) feet to the beginning corner being a portion of the same conveyed to L.
