by and between Lella T. McKinney:

party of the first part, and the MECHANICS BUILDING AND LOAN ASSOCIATION, of Greenville, S. C., a corporation, party of the second part;

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Three thousand dollars.

Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and for further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece parcel and lot of land lying in Greenville County in the State aforesaid, as follows, to-wit:

In Greenville County, about three miles northwest of the City of Greenville, being known as lot no. 13 on plat of property of Lella T. McKinney, a revision of lots nos. 12 and 13 of the Colonia Company, said revision being platted by Dalton & Nease, Engineers, September, 1926, and plat recorded in R. M. C. Office for Greenville County in plat Book 78, page 34, and having the following metes and bounds: Beginning at a stake on the east side of Franklin Road, joint corner of lot no. 12-a and running thence with line of lot no. 12-a, S. 46-16 E. 201 feet to stake; thence N. 35-42 E. 47 feet to stake in line of lot no. 14; thence with line of lot no. 14, N. 44-22 W. 202.2 feet to stake in Franklin Road, and thence with Franklin Road S. 45-38 W. 55 feet to the beginning corner, being a portion of the same conveyed to Lella T. McKinney by Colonia Company, by deed dated June 1, 1926, recorded in Book 72, page 420.
