WHEREAS, I, the said Ben Givens, in and by the certain Promise to pay note in writing, of even date with these presents, John K. Huff, well and truly indebted to

in the full and just sum of Three thousand eighty nine & 10/100 dollars (\$3,089.10) Dollars, to be paid January 4th 1927

with interest thereon, from date at the rate of 8 per cent. per annum, to be computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of One per cent.

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said Ben Givens, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said J. K. Huff,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to W. C., the said Ben Givens,

in hand well and truly paid by the said J. K. Huff

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said J. K. Huff his heirs and assigns forever

all that certain piece, parcel, or tract of land lying and being situated in Grove Township, State and County aforesaid, and having the following mites and bounds to wit Beginning at a stone in the branch, Ballards corner, running thence down branch S. 34° 50' E. 8.50 thence S. 64° E. 4.92 to stone 34 thence S. 37.08 E. 14.06 to stone 34 thence S. 75.50 W. 4.14 to stone thence N. 79.25 W. 14.62 to stone 34 thence N. 63.25 W. 25.06 to iron pin 34 thence N. 72.25 E. 24.50 to the beginning corner, containing thirty nine and seven tenths (39.7) acres more or less, this being the same piece of land conveyed to me by J. K. Huff, by his deed of even date with this paper.
