SEND GREETING:

WHEREAS, I, the said Ella W. Gentry, in and by my certain promise, even date with these presents, to E. W. Carter, in the full and just sum of Thirteen hundred and twenty-five and no/100 Dollars, to be paid one year after date,

with interest thereon, from date at the rate of 12 1/2 per cent. per annum, to be computed and paid quarterly,

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 2 1/2 per cent.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said E. W. Carter, all that certain piece of land,

tract of land situate lying and being in the State and County aforesaid, in Saluda Township, on the waters of North Saluda River and containing Nine and one-half ($9 \frac{1}{2}$) acres, more or less, and having such metes and bounds as shown by plat by J. G. Talley, Surveyor, dated August 22, 1891. Said plat not yet recorded, for metes and bounds of the above land see said plat, less however five acres more or less, said land being bound by the lands of John Starney, V. C. Bailey, J. M. Swiner and others, being the same land conveyed to me by E. W. Carter, Feb. 26, 1926.
