with interest thereon, from Date at the rate of 8 per cent. per annum, to be computed and paid.

Annually is PAID IN RUMENT

until REBUTTERY SECURED, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time paid and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing, for an attorney's fee of FULL AND 30th PAY.

One thousand four hundred six besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear).

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Arch Jamison his heirs and assigns

forever, All that certain piece, parcel or tract of land in the County of Greenville in the state aforesaid about one and three fourth miles from the Court house on the Laurens Road, containing ten and one fourth acres, more or less and having the following metes and bounds, corners and distances Beginning at P. O. in the Laurens Road, thence N. $57\frac{1}{3}$ W. 402 to a stone, thence S. $61\frac{1}{2}$ W. 1047 to a stone, thence S. $21\frac{3}{4}$ E. 735 to a stone, thence N. $63\frac{1}{2}$ E. 15.55 to a stone, the beginning corner, bound by lands of Holcombe, Glenn and others, being the same tract of land conveyed to T. J. Scott by A. C. Scott and being the same tract of land conveyed to me by T. J. Scott on the 1st day of March 1905 by deed duly recorded in the office of Greenville County in vol. 000 at page 5.
