with interest thereon, from *Date* at the rate of *8* per cent. per annum, to be computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Five percent*.

*THE DEBT HEREIN SECURED IS PAID IN FULL AND THE LIEN OF THIS INSTRUMENT IS SATISFIED* *J. Waller Peden* besides all costs and expenses of collection, to be added to the amount due on said note....., to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note....., reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN, That *J. A. Thompson*, the said *J. A. Thompson*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *J. Waller Peden*,

according to the terms of said note..... and also in consideration of the further sum of Three Dollars, to *me*, the said *J. Waller Peden*, in hand well and truly paid by the said *J. Waller Peden*.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *J. Waller Peden*

All that piece <sup>BY WITNESS</sup> or lot of land situate lying and being in <sup>the</sup> *Greenville Township County and State aforesaid*, and being more fully described as follows: Beginning at an iron fence post and running thence N. 63° 41' E. 21'. 20 to stone on branch, thence down branch 10. 87 to a black gum on base of branch thence S. 64° 3/4 W. 11. 10 to a stone, thence S. 57° 1/2 W. 6. 97 to a pine, thence N. 25° 30' W. 10. 94 to the beginning corner and containing 19 7/100 acres more or less.

Also all that other piece, parcel or lot of land situate lying and being in <sup>the</sup> *Greenville Township County and State aforesaid*, and described as follows: Beginning at a stone on base of branch and running thence up said branch 1. 31 chains to a maple, thence S. 68° 1/2 W. 21. 40 to iron pine, thence S. 20° 1/4 E. 1. 10 to iron pine, thence N. 63° 41' E. 21. 20 to the beginning corner and containing two and three fourths acres, more or less said land being the same conveyed to me by *J.
