SEND GREETING:

WHEREAS, I, the said *J. J. Gaunt*,  
 in and by *me* certain *process* *day* *in* *month* *year* *note* in writing, of  
 even date with these presents, *am* *now* *well and truly indebted to*  
*W.M. Bank of Mountain View, S.C.*  
 in the full and just sum of *Three Hundred*  
 Dollars, to be paid *On or before* the *first day of January of 1927.*

with interest thereon, from *the day of* *1926* *at the rate of* *8* per cent. per annum, to be  
 computed and paid *every month* *in advance*  
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
 interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,  
 who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *five* *percent*.

besides all costs and expenses of collection, to be  
 added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
 any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference  
 being thereunto had, as will more fully appear.)

in hand well and truly paid by the said *W.M. Bank*.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,  
 bargain, sell and release unto the said *W.M. Bank* *his heirs and assigns*,

All that certain piece of land situate  
 for and near the town of Mountain View in Greenville  
 County and State aforesaid, containing  
 four (4) acres more or less; fronting on Jones  
 Mill Road about 100 feet bounded on the west  
 by lands of W. B. Garrett, estrade Thomas & Dr.  
 G. J. Samwick, G. G. Garrett et al. on the north by  
 J. S. Gaunt, on the east by lands of Lou Gaunt Estate  
 and on the south by Jones Mill Road. This being  
 the same four acres of land conveyed to me by  
 deed of Mr. Lou Gaunt, said Deed being recorded  
 in the R. M. C. Office for Greenville County in Deed  
 Book 65 at page 239. Reference also being made  
 to a Plat made by J. A. Adams Surveyor March  
 2, 1911 and being known and designated upon  
 said Plat as Lot No. 1 of the lands of the Estate  
 of Crayton Gaunt, deceased. I hereby represent  
 that this is the first and only mortgage or  
 encumbrance on the herein described land.
